



ST. PETERSBURG BAR ASSOCIATION POLICY ON SALE OF ADDRESS LABELS

Address labels may only be used one time and may not be incorporated into any type of data base. Purchasers must sign this Agreement for Purchase of Address Labels before labels will be released.

In general, address labels may be purchased for mailings related to law-related purposes (lawyer or law firm announcements, announcements for judges, state attorney, public defender, and other law-related positions), continuing education seminars, and charitable causes/organizations. Labels are provided to businesses through annual sponsorship agreements only.

Printed labels will be available for pick-up at the St. Pete Bar office. The purchaser must provide a copy of the item(s) that will be mailed together with the Agreement for Purchase of Address Labels. All mailings require the approval of the Executive Director.

Member and Non-profit 501(c)(3) Rate

- **\$150.00 (plus 7% sales tax)**

Non-Member Rate

- **\$375.00 (plus 7% sales tax)**

Sale of Address Labels of St. Pete Bar Members (Specific Sections or Committees)

- **\$50.00 Member and Non-profit Rate; \$75 Non-Member Rate (plus 7% sales tax)**

The St. Pete Bar also sells address labels for a specific Section or Committee, i.e. Family Law, Trial Practice, Probate, etc. These labels can be sold only for the same purposes listed above.

- Labels mailed for an additional charge of \$5.00. Same day labels rush fee - \$25.00
- Labels sorted alphabetically or by zip code order, with or without judges.
- Members may not purchase labels at the member rate for use by non-members.
