In general, eblast announcements may be purchased for **law-related purposes only** including lawyer or law firm announcements; announcements for judges, state attorney, public defender, and other law-related positions; or continuing education seminars.

### Member and Non-profit 501(c)(3) Rate

- **\$150.00**

### Non-Member Rate

- **\$375.00**

### Eblast to Specific Sections or Committee

- **\$50.00 Member and Non-profit Rate; \$75 Non-Member Rate**

The St. Pete Bar also sells eblast announcements for a specific Section or Committee, i.e. Family Law, Trial Practice, Probate, etc. These eblasts can only be used for the same purposes listed above.

- Announcements from the Court, Clerk's Office or The Florida Bar are free of charge.

- *Payment must be received in advance of eblast.*
