Eligibility

Students who meet the following criteria are eligible for the scholarship. The candidate:

- is a resident of Lake County;
- is a citizen of the United States of America; and
- is a graduating Lake County high school senior.

Application Process

Application materials must be received by _____ in order to be considered. The following materials should be submitted:

1. Completed application form.
2. A typed essay (no more than two pages double spaced with 12 point font) addressing the following topic:

James Durden exhibited dignity and achieved greatness in the face of adversity. In so doing, he changed Lake County forever. Describe obstacles you have overcome in your life and how your experiences, characteristics, goals, and achievements may allow you to impact your community like Mr. Durden did.

3. One letter of reference or recommendation from a teacher, coach, or other adult who is not an immediate relative.
4. Letter of acceptance at an accredited 4-year university or community college.
5. Official high school transcripts.

Selection Process

The recipient will be selected by the Lake County Bar Association based on the submitted application materials. All scholarship applicants will be notified of the committee's decision _____. Payment will be made to the recipient's school of choice in accordance with the school's scholarship guidelines.

Purpose of Scholarship

To provide financial assistance to a student with an interest in pursuing continuing education in any field.

Award

One year scholarship in the amount of \$1,000.00, payable to the recipient's educational institution or tuition and/or books, as needed.
