### Scott Westheimer, 2023-2024 Florida Bar President -Elect

Incoming Florida Bar President, Scott Westheimer is a partner at Syprett Meshad, PA. She currently serves on the American Bar Association's Standing Committee on Professionalism. She regularly speaks to legal professionals, law school students, and Florida Bar staff on general professionalism, mindfulness-based emotional intelligence, the impacts of loneliness, mentoring, networking, gratitude, resilience, interpersonal communication skills, active listening, implicit bias, and team building.

### **Judge Hetal Desai, Florida Division of Administrative Hearings**

Hetal Desai is an Administrative Law Judge (ALJ) with the Division of Administrative Hearings. Judge Desai is the host of "Never Contemplated," a podcast produced by the Center for Professionalism that shines a light on legal trailblazers in the judiciary, public service, and legal education.
