OVERVIEW

A panel discussion geared at demystifying the judicial nominating process. Speakers from various JNCs, the Governor's Office and the Judiciary will provide an overview of the Judicial Nominating process from application to appointment by the Governor, including the mechanics of the Judicial Nominating process and tips to be a successful applicant.

- I. Provide an overview of the JNC process from a commissioner's perspective. Discussion will include: the role of the Florida Judicial Nominating Commissions, a peak behind the curtain about the work of the commissions and understanding the judicial application process. Also, will discuss deadlines, applications, interviewing, reference contacts, & community support. Presentations by current and former JNC commissioners.
- II. Discussion of the JNC process from a former applicant's perspective. Presentations by state court judges that have successfully, and unsuccessfully made it through the process.
- III. Overview of the appointment process from the Governor's Office perspective. Discussion will include what the governor is looking for in a nominee, preparing for interviews with the governor, references, career paths, retention process and more. Presentation by Governor's Counsel office.





- IV. Discussion of available resources from voluntary bars and other organizations available to applicants. Discussion will include application reviews, mock interviews, past interviews studies, and more. Presentations by leaders from minority voluntary bars.

SPEAKERS

Miranda Soto is a Shareholder and Chair of the Product Liability Practice Group at Buchanan and is Board Certified in Civil Trials by The Florida Bar. Judge Fine served as a circuit judge for the Eleventh Judicial Circuit from 2012 to 2023, serving in the Juvenile Dependency, Criminal, Civil, and Complex Business Litigation Divisions. Judge Fine received his bachelor's degree from Princeton University and earned a J.D. from the University of Florida.

Fred Karlinsky is a Shareholder and Co-Chair of Greenberg Traurig's Global Insurance Regulatory and Transactions Practice Group. Ray Treadwell, Chief Deputy General Counsel Governor's Office- formerly an Orlando- based Shutts & Bowen senior attorney, currently Chief Deputy General Counsel for Governor Ron DeSantis. He has litigated a wide range of complex commercial cases, including contract and insurance disputes, statutory and constitutional challenges, and employment disputes. Before Shutts, Treadwell was with Holland & Knight in Jacksonville, where Gov. Ron DeSantis once also worked. He also clerked for U.S. District Judge Marcia Morales Howard in Jacksonville. He graduated from the University of Florida in 2004 with honors and from Yale Law School in 2011 where he was a Senior Editor of the Yale Journal on Regulation.
