3. Invocation and Pledge of Allegiance

4. Point of Personal Privilege

President Scott Westheimer asked for a moment of silence to commemorate the deaths of U.S. Supreme Court Justice Sandra Day O'Connor, former Bar President James Fox Miller, former board member Sammy Cacciatore, Jr., and Roland Sanchez-Medina, Sr.

5. Remarks, Florida Supreme Court Chief Justice Carlos Muñiz

The Supreme Court is reviewing the Judicial Circuit Assessment Committee report. Salary enhancements for trial and district court of appeal judges are a priority. Justices will enhance the Supreme Court visitor experience.

6. Remarks, First Circuit Court Chief Judge John Miller

The First Judicial Circuit recovered from a major cyberattack and restored nearly all compromised data. Florida lawyers should invest in cybersecurity, staff training, offsite backup systems, and incident response plans.

8. Minutes Approval

The board approved the minutes from the September 5, 2023, meeting, the September 8, 2023, meeting, and the grievance minutes from the September 8, 2023, meeting. That approval included the following actions taken by the Executive Committee:

- At an October 9, 2023, Executive Committee meeting the committee voted 8-0 to take no action on six legislative position requests that included three from the Business Law Section and three from the Real Property, Probate & Trust Law Section.
- At an October 4, 2023, meeting the Executive Committee voted 11-0 to authorize a settlement offer of up to \$375,000.
- At an October 2, 2023, meeting the Executive Committee voted 12-0 to approve settlement authority in the case regarding the Bar's lease in Tampa and a budget amendment to add this case to the Bar's litigation fund.
- At a September 13, 2023, meeting the Executive Committee voted 12-0 to deny a CLE Committee request to file a comment in SC2023-0884 concerning *"In Re: Code for Resolving Professionalism Referrals and Amendments to Rule Regulating The Florida Bar 6-10.3."*

9. Consent Calendar

After agreeing to withdraw Item 6(a), the board approved the consent agenda, which included the following items:

• A Family Law Section legislative position request that supports amendments to current legislation that increases security for general magistrates, child support

hearing officers and their administrative assistants, including but not limited to expanded confidentiality and criminalization of threats or harassment.

- A Family Law Section legislative position request that opposes legislation that permits a parent to make non-emergency unilateral changes to court-ordered timesharing exchange locations unless the parenting plan provides for sole parental responsibility or ultimate decision-making authority to the parent wishing to change the location, or there is a finding of domestic violence or child abuse by or against the other parent.
- A Real Property, Probate & Trust Law Section legislative position request that supports legislation that provides for the continued rights of a ward to receive visitors and communicate with others when such contact would not be potentially harmful to the ward. A Real Property, Probate & Trust Law Section legislative position request that opposes legislation that would: a. allow for jury trials in proceedings initiated under Chapter 744, b. allow for trials in proceedings related to contesting the validity of wills or revocable trusts prior to the death of the testator/settlor, except as otherwise provided by law, c. require the re-evaluation of wards without the filing of a suggestion of capacity or exercise of the court's discretion, d. require a guardianship proceeding to be transferred to a new judge after the establishment of a guardianship without a substantive basis, or, e. provide for a blanket requirement that any and all family members of the ward related by blood, marriage, or adoption, have access to guardianship inventories, accountings, or other financial information of the ward.
- An Animal Law Section legislative position request that supports legislation on humane cosmetics testing. An Animal Law Section legislative position request that supports legislation that requires adoption of dogs and cats when they are no longer used for research. An Animal Law Section legislative position request that supports legislation to create a statewide animal abuse registry.
- A Trial Lawyers Section legislative position request that opposes that portion of SB 248 that seeks to include requirements of a probable cause finding by an administrative agency as a condition of recovery of damages. The provision would apply to disciplinary proceedings set forth in section 456.073(4) against a health care practitioner licensed by the Florida Department of Health and would amend section 768.21 to state that absent a finding of probable cause no such damages could be recovered. The Trial Lawyers Section believes this is a denial of access to the courts by the citizens of the State of Florida.
- A legislative advising agreement between the Animal Law Section and Ralph DeMeo, Macie Codina, and Diana Ferguson.
- A judicial conference legislative advising agreement between The Florida Bar and Megan Fay of Capital City Consulting.
- A judicial conference legislative advising agreement between The Florida Bar and Peter M. Dunbar of Jones Walker.
- A judicial conference legislative advising agreement between The Florida Bar and Stephen W. Shiver, Jr., of the Advocacy Group at Cardenas Partners.

10. Executive Director's Report

Lawyer Regulation Division Director Elizabeth Tarbert presented.

The Civil Procedure Rules Committee chair conducted training for division lawyers on civil discovery rules. Outside counsel provided training on summary judgment. Division lawyers observed Florida Lawyers Assistance, Inc. programs. The division is developing training for local professionalism panels. Based on an internal review, the division has improved the documenting of Bar case conflicts and extension requests. The division is developing a procedure for random review of case closures. The division worked with the Disciplinary Procedure Committee to improve communication with complainants and develop new standing board policies. The division adopted a policy regarding complaints against Bar staff. The division is considering electronic service of the initial, 15-day letter notifying members of a complaint.

11. Legislation Committee Report

Chair R. Sia Baker-Barnes presented.

Items on Final Action: Proposed amendments to Standing Board Policy 9.10 (Authority), Standing Board Policy 9.11 (Definitions), Standing Board Policy 9.20 (Action by Board), Standing Board Policy 9.50 (Technical Assistance and Legislative and Political Activities of Voluntary Florida Bar Groups), and Standing Board Policy 9.51 (Procedure for Retaining Voluntary Florida Bar Group or Legislative or Political Advisors). The board voted without objection to approve.

The Legislature will conduct two more interim committee weeks before session convenes January 9, 2024. Bar leaders are promoting branch priorities to House and Senate leaders. The governor releases a budget proposal next week.

12. Outside Counsel's Report

Attorney Kevin Cox presented.

The Florida Bar is appropriately focused on the core missions of regulating the practice of law and improving the delivery of legal services to the public. A subcommittee will report to the board in January after reviewing *Boudreaux v. Louisiana State Bar Association*.

13. Disciplinary Procedure Committee Report

Chair Tad Yates presented.

Items on Final Action: Proposed amendments to Rule 3-5.1 (Generally), Rule 3-5.3 (Diversion of Disciplinary Cases to Practice and Professionalism Enhancement Programs), Rule 3-7.11 (General Rule of Procedure), Rule 3-7.16 (Limitation on Time to Open Investigation) and Standing Board Policy 15.10 (Waiver of Disqualification). The board voted without objection to approve.

14. Special Committee on Al Tools & Resources Report

Co-Chair Gordon Glover presented.

The committee proposed new comments to Bar rules regarding a lawyer's duty to understand the risks and benefits associated with generative AI, and the responsibility to maintain confidentiality and consider safeguards when using generative AI. The committee submitted a request for Proposed Advisory Opinion 24-1 that addresses confidentiality, lawyer oversight, legal fees and costs, and lawyer advertising. The committee vetted possible certification and disclosure requirements for lawyers and prose litigants. The committee requested the Rules of General Practice and Judicial Administration Committee to review Rule 2.515. The committee asked the Code and Rules of Evidence Committee to consider integrating digital watermarking, blockchain verification and other innovative AI detection tools into the rules governing the admissibility of evidence. The committee is working with Bar staff to develop educational resources for Florida lawyers on the risks and benefits of generative AI.

15. President's Report

About 200 comments have been submitted in Supreme Court Case SC2022-1292 regarding proposed amendments to Rule 5-1.1. The Judicial Circuit Assessment Committee recommended not consolidating any of Florida's judicial circuits. About 300 law firms have implemented the free trust accounting solution Nota. Tickets are available for the January 18, 2023, Supreme Court Historical Society dinner.

16. Special Appointments

President Scott Westheimer presented.

The 2022 Supreme Court Judicial Nominating Commission: Board member Alice Sum moved to nominate William J. Schifino, Jr., Michelle Renee Suskauer, Daniel Elden Nordby, Thomasina Moore, and Richard Chambers Valuntas. The board went into executive session to discuss confidential matters. The board returned to public session and voted to reject the slate. Board member Alice Sum moved the nominations of William J. Schifino, Jr., Daniel Elden Nordby, Thomasina Moore, Richard Chambers Valutas, and Eric Allan Lee. The board voted to approve.

17. Technology Committee Meeting Report

Chair Alice Sum presented.

A subcommittee is developing a daylong, AI-themed presidential showcase for the Annual Convention. A second subcommittee is developing a webpage to highlight AI, technology, and ethics-related resources for Florida Bar members.

18. Executive Session

The board went into executive session to discuss confidential matters.

19. Probate Rules Committee Report

Board member Sandra Diamond presented.

Items on Final Action: Proposed Amendments to Rule 5.025 (Adversary Proceedings) and Rule 5.340 (Inventory). The board voted 35 to accept, 0 to reject.

20. Board Review Committee on Professional Ethics Report

Chair Brian Burgoon presented.

Items on Final Action: Proposed amendments to Rule 4-4.4(a) of the Rules Regulating The Florida Bar. If approved, the proposed amendments would add language to the rule that explicitly prohibits a lawyer from threatening false reviews or social media posts that impugn another person or entity. After discussion, the board voted to reject the proposed amendments.

Review of proposed Advisory Opinion 23.-1. If approved, Proposed Advisory Opinion 23-1 would permit a Florida lawyer to be a passive investor in an "alternative business structure" in another jurisdiction subject to specific restrictions, including that the "alternative business structure" did not engage in the practice of Florida law. After consideration of comments received regarding the proposed advisory opinion, the board voted to disapprove finalization and publication of the opinion. A motion was then made and seconded to withdraw Proposed Advisory Opinion 23-1. The motion to withdraw the proposed advisory opinion was approved.

Review of Ethics Inquiry 43517. Staff's opinion, dated March 27,2023, concluded that a nonlawyer is prohibited from using the title "Chief Executive Officer" pursuant to Rule 4-8.6(c) of the Rules Regulating The Florida Bar. The Professional Ethics Committee affirmed staff's opinion on June 23, 2023, and the inquirer sought board review. The board voted to affirm staff's opinion and the decision of the Professional Ethics Committee.

21. Florida Lawyers Assistance, Inc., Report

Executive Director Daniel J. McDermott presented.

FLA was created in 1986 as an independent non-profit organization stemming from a Florida Supreme Court determination that substance use disorders and mental health conditions are medically recognized and treatable. FLA contracts with more than 1,300 lawyers who agree to random drug screening, attend group meetings, and meet regularly with an FLA monitor. FLA sponsors 42,000 hours of support group involvement every year for judges, lawyers, and paralegals. FLA has contracted with 5,300 lawyers since 1986. Only nine lawyers who successfully completed a contract have been re-referred for behavioral issues.

Proposed Amendments to Chapter 4 Preamble, and Rule 4-1.3 (Diligence). After discussion, the board voted 24-9 to approve.
